This registration statement relates to the Company's prior registration statement on Form S-11 (Registration No. 333-187318), originally filed on March 15, 2013, as amended (the Prior Registration Statement), which was declared effective on April 25, 2013. The contents of the Prior Registration Statement, including all exhibits thereto, are incorporated by reference herein. This registration statement covers the registration of additional shares of the Company's common stock described in the prospectus constituting a part of the Prior Registration Statement having a maximum aggregate offering price of \$48,437,500.
