Medtronic, Inc. (Medtronic) and Covidien plc (Covidien) today confirmed that they expect the closing of Medtronic s acquisition of Covidien to occur in early calendar year 2015. This is based on, among other things, Medtronic s and Covidien s current views of the timing required to finalize the joint proxy statement/prospectus, obtain necessary regulatory and shareholder approvals and thereafter obtain approval of the Irish High Court and is consistent with prior guidance that indicated closing was expected to occur in the time period between late calendar year 2014 and early calendar year 2015.
