Sears Holdings Corporation ( Sears Holdings ) is a holding company that conducts operations through its subsidiaries, and is the parent company of Kmart Holding Corporation and Sears, Roebuck and Co. (collectively, the Domestic Operating Companies ). On April 4, 2014, Sears Holdings completed the separation of its Lands End business through a spin-off transaction, and on October 16, 2014, Sears Holdings completed the de-consolidation of Sears Canada Inc. ( Sears Canada ) through a rights offering of 40 million common shares of Sears Canada.
