Question: How will going to a privately-controlled model with Dell change the way employees are compensated?

Answer:

It's great to have this opportunity to address hot topics. There's a three part answer to that question.

So the first part is, there is a commitment, as we join the new company and we become private, that EMC employees will enjoy the same cash compensation they enjoy today. So the salary and bonus plans will not change when the transaction closes.

On top of that, we will be looking at what the benefit plans are across the combined company. There might be a few minor changes, as we choose individual programs, but the plan is to try and keep people reasonably whole along the benefits side.

And then last but not least, in a public company we have things like equity based compensation on top of salary and bonus. In a private company, that typically gets replaced by mechanisms like restricted cash and other forms of cash based compensation.

We'll know a lot more as we get nearer to the close of the transaction, in mid-2016.
