## Explanation of Responses:

The Restricted Performance Shares vest based on the Company's return on equity for the period that begins on July 15, 2008 and ends on July 15, 2011 (the "performance period") as follows: (a) if the Company's return on equity for the performance period equals or exceeds two hundred percent (200%), the Restricted Performance Shares will fully vest; (b) if the Company's return on equity for the performance period is less than two hundred percent (200%) but equal to or greater than one hundred sixty percent (160%), then twenty-percent (20%) of the Restricted Performance Shares will vest, plus 0.4 percent (0.4%) for each one-tenth of a percent by which the return on equity exceeds one hundred sixty percent (160%); and (c) if the Company's return on equity for the performance period is less than one hundred sixty percent (160%), the Restricted Performance Shares will not vest.
