In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon (i) any transfer, whether or not for value (subject to certain exceptions) or (ii) in the event of death of the Reporting Person.
- (2) The transaction was effected pursuant to a Rule 10b5-1 plan dated March 6, 2012.
