- (1) The number of shares shown represents the time-based restricted stock units (TBRUs) that vested on May 16, 2013 and were settled on May 14, 2015. These TBRUs were awarded on May 17, 2012.  
Each TBRU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. These
- (2) TBRUs are valued as of the date of settlement and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.
- (3) The number of shares shown represents the settlement of the 40% cash portion of TBRUs that were settled and paid on May 14, 2015. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.
- (4) These TBRUs were awarded on May 17, 2012.
- (5) These TBRUs vested 100% on May 16, 2013 and were settled on May 14, 2015.
