On April 29, 2015, the reporting person received a grant, subject to shareholder approval, of 75,000 restricted stock units, convertible into (1) common stock of the issuer on a one-for-one basis. Shareholder approval was obtained June 2, 2015. The restricted stock units vest in three approximately equal installments on March 21, 2016, 2017 and 2018, subject to accelerated vesting under certain conditions.
