(1) Grant of restricted stock units (RSUs) pursuant to the Issuer's 2013 Stock Incentive Plan. With respect to the perf.-based RSUs, if the continued service requirement is satisfied and achievement of the perf. goal (x) exceeds 100% of target, the Issuer may issue additional vested shares of common stock in an amount that corresponds to the incremental
