Vesting will be accelerated if the fuel load authorization for Unit 3 and Unit 4 is received from U.S. Nuclear Regulatory Commission before December 31, 2022. Additional units will be acquired with deemed dividends. Shares will be withheld upon vesting to satisfy tax requirements.
