The holdings are net of shares previously withheld or sold to cover withholding taxes.
- On November 24, 2014, the Company awarded 1,400 restricted shares under the Company's 2012 Stock Incentive and Award Plan.
- (2) One-third of the restricted shares vested on each of November 24, 2015 and 2016, and one-third will vest on November 24, 2017. 196 of the 466 shares that vested November 24, 2016 were withheld to cover withholding taxes due upon vesting.
