Pursuant to the instructions in Item 7 of Schedule 13G, Advisory Research, Inc. ("ARI"), 180 N. Stetson, Chicago, IL 60601, a wholly-owned subsidiary of Piper Jaffray Companies and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 1,198,175 shares or 11.5% of the Common Units Representing Limited Partner Interests outstanding of Oxford Resource Partners LP ("the Company") as a result of acting as investment adviser to various clients.

Piper Jaffray Companies may be deemed to be the beneficial owner of these 1,198,175 shares through control of ARI. However, Piper Jaffray Companies disclaims beneficial ownership of such shares.
