(1) This transaction was made pursuant to a Rule 10b5-1 Plan adopted by the reporting person on November 24, 2015.

(2) The price reported in Table I - Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$35.754 to \$36.41. Only vested shares can be exercised under this option. The options were set to expire in 2017.
