(1) On December 30, 2013, 75,000 restricted stock units held by Mr. Walther vested. Pursuant to the terms of his restricted stock unit award, the Company withheld 39,135 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
Following the transaction reported on this Form 4, Mr. Walther held, indirectly through the Walther-Stockton 2013 Family Trust, (A)
(2) 51,695 shares of the Company's common stock and (B) 200,000 restricted stock units, each representing the right to receive one share of the Company's common stock, 120,000 of which have performance-based vesting conditions.
