- (1) The reporting person agreed to the forfeiture of 14,350 shares of unvested restricted stock granted to him on May 6, 2008, the forfeiture of 27,236 shares of unvested restricted stock granted to him on January 21, 2009, and options granted to him on March 6, 2008, in exchange for a new option having a lower exercise price.
