Represents a "net exercise" of outstanding stock options. These shares were withheld by Hanesbrands Inc. for payment of the exercise price and applicable taxes, based on the market price of Hanesbrands Inc. common stock at the time of the option exercise on April 7, 2015 of \$33.99.

This transaction was executed in multiple trades at prices ranging from \$33.79 to \$34.13. The price reported above reflects the weighted average sale price.
