- (1) On May 2, 2008, Mr. McNutt was awarded 213,400 shares of restricted stock under the Boise Inc. Incentive and Performance Plan, which was reported on Mr. McNutt's Form 4 filed with the SEC on May 6, 2008. A portion of this 2008 award vests with the passage of time (service-condition vesting restricted stock) and the remaining portion vests only if the company achieves specific performance hurdles (market-condition vesting restricted stock). The first 1/3 of Mr. McNutt's service-condition vesting restricted stock vested in full on March 2, 2009, and Mr. McNutt paid the withholding tax on those shares. The second 1/3 of Mr. McNutt's service-condition vesting restricted stock vested in full on March 1, 2010, and Mr. McNutt elected to have shares withheld to satisfy his tax withholding obligation.
