The restricted stock will vest over a three-year period at a rate of 10,000 shares per year, conditional upon the Company achieving in Fiscal Year 2011 both revenue greater than \$23,000,000 and operating profit greater than \$2,350,000; and in FY 2012 revenue greater (1) than \$28,425,000 and operating profit greater than \$3,168,000; and in FY 2013 revenue greater than \$33,437,000 and operating profit greater than \$3,820,000; or cumulatively achieving revenue greater than \$84,862,000 and operating profit greater than \$9,338,000 at any time during the three-year period.
