On March 15, 2012, Ashford Hospitality Trust, Inc. (the “Company”) issued a press release announcing that its Board of Directors:

a) declared a common stock dividend for the first quarter ending March 31, 2012, of \$0.11 per diluted share, payable April 16, 2012, for shareholders of record on March 30, 2012.

b) declared a dividend for the first quarter ending March 31, 2012, of \$0.5344 per diluted share, for the Company’s 8.55% Series A Cumulative Preferred Stock. This dividend is payable April 16, 2012, for shareholders of record on March 31, 2012.

c) declared a dividend for the first quarter ending March 31, 2012, of \$0.5281 per diluted share, for the Company’s 8.45% Series D Cumulative Preferred Stock. This dividend is payable April 16, 2012, for shareholders of record on March 31, 2012.

e) declared a dividend for the first quarter ending March 31, 2012, of \$0.5625 per diluted share, for the Company’s 9.00% Series E Cumulative Preferred Stock. This dividend is payable April 16, 2012, for shareholders of record on March 31, 2012.
