Item 1.01 Entry into a Material Definitive Agreement.

On January 24, 2015, Altisource Residential Corporation (the “Company”) entered into a servicing agreement with Fay Servicing, LLC (“Fay Servicing”). Under the servicing agreement, Fay Servicing will subservice and provide certain administration, management, modification and disposition services for residential mortgage loans and REO properties acquired by the Company and its subsidiaries from time to time.

The servicing agreement will continue in force until termination upon the mutual consent of the parties, termination by the Company upon certain events of default or termination by the Company without cause upon 30 days prior written notice.

The disclosures herein regarding the servicing agreement do not purport to be complete and are qualified in their entirety by reference to the full text of the servicing agreement which will be filed as an Exhibit to the Company’s Form 10-K for the year ended December 31, 2014.
