- (2) Held by a revocable trust established for the benefit of Ms. Malone's daughter. Ms. Malone is a trustee of the trust and disclaims beneficial ownership of these shares. These shares were reported on previous Form 4s as indirectly held by "Trusts for Children".
- (3) Held by Contango LP, of which Hera Management LLC, a single member LLC of which Ms. Malone is the sole member, is the general partner. Ms. Malone disclaims beneficial ownership of all of the above shares except to the extent of her pecuniary interest therein.
- (4) Held by Hera Management LLC, of which Ms. Malone is the sole member. Ms. Malone disclaims beneficial ownership of all of the above shares except to the extent of her pecuniary interest therein.
