As a result of a 3-for-2 stock split effective 10/18/2006 this option is now for 22,500 shares at \$9.50 per share.
  - (2) Original 7/19/2000 option was for 15,000 shares at \$14.25 per share. 7,017 shares were vested on 7/19/2000; 7,017 shares were vested on 1/1/2001; and 966 shares were vested on 1/1/2002. As a result of a 3-for-2 stock split effective 10/18/2006 this option is now for 22,500 shares at \$9.50 per share. On April 23, 2010 1,000 shares were exercised and on May 18, 2010 1,500 were exercised at \$9.50 per share, leaving a balance of 20,000 shares.
