Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 10,123,335 shares or 15.000% of the Common Stock outstanding of Freedom Acquisition Holdings Inc ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of Freedom Acquisition Holdings Inc owned by the investment companies at July 31, 2007 included 2,688,900 shares of Common Stock

resulting from the assumed conversion of 2,688,900 shares of FREEDOM ACQUISN WTS 12/21/11 (1 shares of Common Stock for each Warrant). The number of shares of Common Stock of Freedom Acquisition Holdings Inc owned by the investment companies at July 31, 2007 included 2,467,000 shares of Common Stock resulting from the assumed conversion of 1,233,500 shares of FREEDOM ACQUISN (1CS & 1WT) UNIT (2 shares of Common Stock for each Unit).

The ownership of one investment company, Fidelity Advisors Small Cap Fund, amounted to 4,635,778 shares or 6.869% of the Common Stock outstanding. Fidelity Advisors Small Cap Fund has its principal business office at 82 Devonshire Street, Boston, Massachusetts 02109.

Edward C. Johnson 3d and FMR Corp., through its control of Fidelity, and the funds each has sole power to dispose of the 10,123,335 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR Corp., are the predominant owners, directly or through trusts, of Series B shares of common stock of FMR Corp., representing 49% of the voting power of FMR Corp. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B shares will be voted in accordance with the majority vote of Series B shares. Accordingly, through their ownership of voting common stock and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR Corp.

Neither FMR Corp. nor Edward C. Johnson 3d, Chairman of FMR Corp., has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.
