- (1) This Form 4 reflects UMH Properties, Inc. purchase of 30,000 shares of Monmouth Real Estate Investment Corporation on 8/15/2008 through the Dividend Reinvestment and Stock Purchase Plan. In addition, UMH owns \$1,000,000 principal amount of the 2003 Debentures, representing 109,170 shares of the Issuer's Common Stock on a converted basis, and \$5,000,000 principal amount of the 2005 Debentures, representing 436,681 shares of the Issuer's Common Stock on a converted basis. The total number of securities of the Issuer beneficially owned at this time includes 545,852 shares of Common Stock of the Issuer issuable upon conversion of the 2003 and 2005 Debentures.
