On September 18, 2015, Norfolk Southern issued a press release announcing plans to restructure the operations of its subsidiary Triple Crown Services Company ("TCS") to focus on automobile parts business between Detroit and Kansas City. Norfolk Southern expects that the TCS workforce will be downsized by about 200 employees by the end 2015 and will recognize accelerated depreciation and other costs totaling approximately \$65 million in the third and fourth quarters of 2015.
