The net loss applicable to common stock for the first quarter of 2003 is expected to be approximately \$35 million. The net loss applicable to common stock for the first quarter of 2002 was \$3,046.1 million. The loss recognized in the first quarter of 2002 includes the cumulative effect of an accounting change for goodwill impairment of \$2,949.2 million pursuant to the adoption of Statement of Financial Accounting Standards No. 142, "Goodwill and Other Intangible Assets".
