On December 23, 2003, California Amplifier, Inc. (the "Company") signed a definitive agreement (the "Agreement") to acquire Vytek Corporation ("Vytek"), a privately-held company headquartered in San Diego, California engaged in providing hardware and software products and services that enable both wireless and wireline access to information.

The terms of the Agreement provide that California Amplifier will acquire Vytek for fixed number of 8,200,000 shares of California Amplifier's common stock. The transaction is subject to customary closing conditions, including approvals by regulatory agencies and by the stockholders of Vytek and California Amplifier.

California Amplifier will file a registration statement on Form S-4 with the Securities and Exchange Commission to register the offer and sale of shares of its common stock in connection with the proposed merger.

The terms of the proposed acquisition are set forth in the Agreement. The description of the Agreement set forth herein is qualified in its entirety by reference to the full text of the Agreement, which is attached hereto as Exhibit 2.1.
