NV Bekaert had indicated to Research Frontiers that it was focusing on its advanced wire products business which constitutes a reported 90% of its sales.

Research Frontiers is filing this Current Report on Form 8-K because the royalty payment received from NV Bekaert on September 29, 2008 as a condition to such termination was substantial and is likely to have a positive impact on Research Frontiers results of operations for the third quarter ending September 30, 2008.
