The shares will vest on March 31, 2020 if Farmer Mac meets certain performance objectives related to portfolio charge-offs and delinquencies, as specified in the related award agreement, for the period starting on January 1, 2017 and ending on December 31, 2019.
- (5) Exercisable beginning March 31, 2018 with respect to 3,554 shares, beginning March 31, 2019 with respect to 3,554 shares, and beginning March 31, 2020 with respect to 3,554 shares.
- (6) Grant of stock appreciation rights under Farmer Mac's 2008 Omnibus Incentive Plan for no consideration.
