The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC

Guarantor: JPMorgan Chase & Co.

Minimum Denomination: \$1,000

Indices: S&P 500® Index and Russell 2000® Index

Pricing Date: December 27, 2018

Observation Date: December 26, 2023

Maturity Date: December 29, 2023

Contingent Minimum Return: At least 42.00%\*

Buffer Amount: 20.00%

Payment At Maturity: If the Final Value of each Index is greater than or equal to its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{greater of (a) Contingent Minimum Return and (b) Lesser Performing Index Return})$

If (i) the Final Value of one Index is greater than or equal to its Initial Value and the Final Value of the other Index is less than its Initial Value by up to the Buffer Amount or (ii) the Final Value of each Index is less than its Initial Value by up to the Buffer Amount, you will receive the principal amount of your notes at maturity.

If the Final Value of either Index is less than its Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + [\$1,000 \times (\text{Lesser Performing Index Return} + \text{Buffer Amount})]$

If the Final Value of either Index is less than its Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.
