The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Contingent Interest Rate: 5.50%-7.50%\* per annum, paid quarterly at a rate of between 1.375% and 1.875%\*, if applicable

Interest Barrier/Trigger Value: With respect to each Index, an amount that represents 70.00% of its Initial Value.

Automatic Call

If on any Review Date (other than the first, second, third, and final Review Dates) the closing level of each Index is greater than or equal to its Initial Value, the Notes will be automatically called and you will receive a cash payment for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to that Review Date.

Payment at Maturity

If the notes have not been called and the Final Value of each Index is greater than or equal to its respective Trigger Value, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to the final Review Date.

If the notes have not been called and the Final Value of any Index is less than its Trigger Value, at maturity you will lose 1% of the principal amount of your notes for every 1% that the Final Value of the Lesser Performing Index is less than its Initial Value, subject to any Contingent Interest Payment payable at maturity. Under these circumstances, your payment at maturity per \$1,000 principal amount note, in addition to any Contingent Interest Payment, will be calculated as follows:  $\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$ .
