New Mountain Partners pursuant to an irrevocable proxy granted to it on March 16, 2001, was granted the right, along with DB Capital Investors, L.P., to vote the 8,175,000 shares of common stock, par value \$.01 per share, of the Issuer covered by the proxy, subject to certain limitations set forth in the proxy. As a result, the Reporting Person may be deemed for purposes of Section 16 of the Securities and Exchange Act of 1934, as amended, to be a "10 percent holder" hereunder.
