 - (1) On July 5, 2018, BW LPG Holding Limited ("LPG Holding") purchased 100 shares of common stock, par value \$0.01 per share (the "Common Shares"), of Dorian LPG Ltd. (the "Issuer") in order to become a stockholder of the Issuer eligible to make nominations of individuals to stand for election to the Issuer's Board of Directors. LPG Holding is a wholly-owned subsidiary of BW LPG Limited ("BW LPG").
 - (2) As of July 16, 2018, BW Group Limited ("BW Group") owns approximately 45% of BW LPG. BW Group's wholly-owned subsidiary, BW Euroholdings Limited ("Euroholdings"), owns 7,826,460 Common Shares. LPG Holding and BW LPG are filing this Form 3 because BW Group, Euroholdings, The Sohmen Family Foundation, which holds 93.25% of BW Group, LPG Holding and BW LPG may be considered a group within the meaning of Section 13(d)(3) of the Exchange Act.
 - (3) LPG Holding and BW LPG are jointly filing this Form 3 pursuant to Rule 16a-3(j) under the Exchange Act.
