This Schedule 13G is being filed by Gagnon Securities LLC and Neil Gagnon (together, the "Reporting Persons"). Gagnon Securities LLC is an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 that furnishes investment advice to several customer accounts, foundations, partnerships, trusts, and private investment funds (collectively, the "Funds"). Mr. Gagnon is the managing member and the principal owner of Gagnon Securities LLC. In its role as investment manager to the Funds, Gagnon Securities LLC shares voting and/or dispositive power with Mr. Gagnon over certain securities of the Issuer described in this Schedule. Additionally, Mr. Gagnon has sole voting power and sole dispositive power with respect to certain other securities of the Issuer, shares voting power and dispositive power with certain persons with respect to certain other securities of the Issuer, and shares dispositive power with certain other persons with respect to certain other securities of the Issuer but has no voting power with respect to such securities. The Reporting Persons expressly disclaim beneficial ownership of all securities held in the Funds' accounts. No single client's interest as reported in the customer accounts at Gagnon Securities LLC exceeds 5% of the outstanding Common Stock of the Issuer. In addition, the filing of this Schedule 13G shall not be construed as an admission that the Reporting Persons or any of their affiliates is the beneficial owner of any securities covered by this Schedule 13G for any other purposes than Section 13(d) of the Securities Exchange Act of 1934.
