Murray and Walsh and 3,125 shares of the Issuer's Common Stock held by Mr. Stephen McKenna, a former director of the Issuer who was formerly an employee and an affiliate of CCMP Capital, because CCMP Capital has voting and dispositive power over such shares as a result of the contractual arrangements among such persons and CCMP Capital, which provide that such shares are to be held for the benefit of the CCMP Funds and are to be voted or disposed of at the direction of CCMP Capital. As a consequence of being members of the CCMP Capital investment committee that makes voting and disposition decisions with respect to the reported securities, Messrs. Murray, Walsh and Brenneman may be deemed, pursuant to Rule 13d-3 under the Exchange Act, to beneficially own all 14,935 shares of the Issuer's Common Stock held by each of Messrs.
