#### PART III of FORM 12b-25 of NetSol International, Inc.

On June 10, 2001, a group of dissident shareholders illegally took physical control of the Company. On June 11, 2001, the management filed a Temporary Restraining Order ("TRO") with the Nevada District Court to seek relief. The court granted the TRO in favor of the Company; however, also put in place a Receiver. From June 18, 2001 to July 31, 2001, the date the Receiver was removed by the Court, the Receiver was in control of the Company and the management was unable to promptly commence the audit procedures until August 1, 2001. Accordingly, the Registrant's 10-KSB shall be prepared and filed within the granted extension period.
