Due to an unanticipated delay in finalizing the balance sheet impact of deferred taxes, the Registrant did not complete its review and preparation of the financial statements until February 28, 2007. As a result, the Registrant did not have sufficient time to finalize its review and preparation of its Annual Report on Form 10-K (including audited financial statements) before the March 1, 2007 deadline. The Registrant filed the Annual Report on Form 10-K on March 2, 2007, which was within 15 days of the due date.

On February 28, 2006, the Registrant issued a press release announcing financial results for the quarter and year ended December 31, 2006. A copy of the press release is attached as Exhibit 99.1 to the Registrant's

Current Report on Form 8-K dated February 28, 2006.

For the quarter ending December 31, 2006, the Registrant reported total revenues of \$125.4 million, reflecting an increase of \$52.4 million over the fourth quarter of 2005. The Registrant reported net income of \$10.1 million, or \$0.34 per diluted share, for the fourth quarter of 2006, compared to net income of \$10.6 million, or \$0.33 per diluted share, in the fourth quarter of 2005.

Total revenues for the year ended December 31, 2006 were \$419.3 million, reflecting an increase of \$141.4 million over 2005. The company reported net income of \$29.4 million, or \$0.97 per diluted share, for the full year 2006, compared to net income of \$37.2 million, or \$1.15 per diluted share in 2005.
