Smith, Vassalluzzo and Englander share the power to vote or to direct the vote of and to dispose or to direct the disposition of 1,941,848, 1,896,848 and 45,000 shares, respectively. Voting and investment authority over investment accounts established for the benefit of certain family members and friends of the Reporting Persons is subject to each beneficiary's right to terminate or otherwise direct the disposition of the investment account.
