Mariner Energy, Inc. (Mariner) entered into Amendment No. 4, dated as of August 24, 2007, among Mariner and Mariner Energy Resources, Inc., as borrowers, the Lenders (as defined in the Credit Agreement described below), and Union Bank of California, N.A., as administrative agent and as issuing lender for such Lenders (the Amendment), which further amends the Amended and Restated Credit Agreement, dated as of March 2, 2006, among the same parties (the Credit Agreement).

The Amendment amends the Credit Agreement to, among other things, (i) increase to \$100 million certain investments Mariner may make, subject to a liquidity test for those above \$10 million, and (ii) modify hedging restrictions to eliminate separate limitations by geographic producing areas, and increase the percentage of production that may be hedged under, and extend tenor of allowable hedge arrangements to 90% during the first three years and 75% during the fourth and fifth years of any such arrangements.

A copy of the Amendment is attached as Exhibit 4.1 and incorporated herein by reference. The above description of the Credit Agreement, as amended by the Amendment, is a summary and is qualified in its entirety by the complete text of the Amendment and the Credit Agreement which previously was filed.
