**DEREGISTRATION OF SECURITIES**

On May 8, 2002, Prudential Financial, Inc. ( Prudential ) filed a registration statement on Form S-8 No. 333-87778 (the 2002 S-8 ) registering 12,775,000 shares of Prudential 's common stock, par value \$.01 per share ( Common Stock ), for issuance by Prudential under The 2002 Prudential Financial Stock Purchase Program for Eligible Employees of Prudential Securities Incorporated Participating in Various Prudential Securities Incorporated Programs (the 2002 Program ).
