ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On September 1, 2004, the Board of Directors of Belden CDT Inc. (the Company) approved the Company's entering into an indemnification agreement with each director and reporting officer of the Company, those being: Bryan C. Cressey, C. Baker Cunningham, Lorne D.
