ITEM 5.03. AMENDMENTS TO ARTICLES OF INCORPORATION OR BYLAWS; CHANGE IN FISCAL YEAR.

On October 30, 2007, the Board of Directors of Perrigo Company (the "Corporation") approved the amendment and restatement of the Corporation's Bylaws. The Bylaw amendment is intended to clarify the ability of the Corporation to participate in the Depository Trust Company's Direct Registration System ("DRS"). The DRS is a method of recording registered share ownership in "book entry" form without the need for physical paper certificates. The Bylaw amendment makes it clear that the Corporation may issue both certificated and uncertificated shares.
