Represents trust shares (the "Trust Shares") of beneficial interests in P&O Princess Voting Trust (the "Trust"). In connection with the dual listed company transaction between Carnival plc (fka P&O Princess Cruises plc) and Carnival Corporation (the "DLC Transaction"), Carnival plc issued one special voting share to the Trust and, following a series of transactions, the Trust Shares were distributed to

(1) holders of common stock of Carnival Corporation (the "Carnival Corporation Common Stock"). Since completion of the DLC transaction on April 17, 2003, if Carnival Corporation issues Carnival Corporation Common Stock to a person, the Trust will issue an equivalent number of Trust Shares to such person. The Trust Shares are paired with shares of Carnival Corporation Common Stock and are represented by the same stock certificate. The Trust Shares represent a beneficial interest in the Carnival plc special voting share.

(2) Represents a surrender of shares to satisfy the tax obligation on the vesting of restricted stock granted in 2008.

(3) Includes Includes (i) 103,638,843 shares of Trust Shares held by MA 1994 B Shares, L.P.; (ii) 538,393 Trust Shares held by the Nickel 97-07 Trust; (iii) 219,934 Trust Shares held by the Nickel 2008 GRAT, (iv) 2,023,761 Trust Shares held by the Nickel 2008-2 GRAT, (v) 876,929 Trust Shares held by the Nickel 2009 GRAT and (vi) 1,000,862 Trust Shares held by the Nickel 2010 GRAT.
