**USE OF PROCEEDS**

The Company will not receive any proceeds from the sale of shares of the Company's Common Stock by the selling shareholders.

**SELLING SHAREHOLDERS**

The issuance of shares of Common Stock pursuant to the Incentive Plan has been registered under the Securities Act by a Registration Statement on Form S-8. This prospectus is to be used in connection with any resales of the Company's Common Stock acquired pursuant to the Incentive Plan after the date of the Registration Statement by persons who may be considered affiliates of the Company within the meaning of the Securities Act. The selling shareholders will be either employees or executive officers of the Company or its subsidiaries who have been or may be granted restricted shares of the Company's Common Stock under the Incentive Plan.

At the date of this prospectus, the Company does not know the names of persons who intend to resell shares of Common Stock acquired pursuant to the Incentive Plan. The Company will supplement the prospectus with the names of the selling shareholders and the amount of shares of Common Stock to be reoffered by them as that information becomes known.

The shares may be offered by the selling shareholders from time to time in transactions through the New York Stock Exchange, in negotiated transactions, through the writing of options on the shares, or a combination of such methods of sale, at prices related to prevailing market prices, or at negotiated prices. The selling shareholders may effect such transactions by selling the shares to or through broker-dealers, and such broker-dealers may receive compensation in the form of discounts, concessions or commissions from the selling shareholders and/or the purchasers of the shares for which such broker-dealers may act as agent or to whom they sell as principal, or both (which compensation as to a particular broker-dealer might be in excess of customary commissions).

Section 2-418 of the Maryland General Corporation Law generally permits indemnification of any director made a party to any proceeding by reason of service as a director unless it is established that (i) the act or omission of such person was material to the matter giving rise to the proceeding and was committed in bad faith or was the result of active and deliberate dishonesty; (ii) such person actually received an improper personal benefit in money, property or services; or (iii) in the case of any criminal proceeding, such person had reasonable cause to believe that the act or omission was unlawful. The indemnity may include judgments, penalties, fines, settlements and reasonable expenses actually incurred by the director in connection with the proceeding, but, if the proceeding is one by, or in the right of the Company, indemnification is not permitted with respect to such proceeding in which the director has been adjudged to be liable to the Company. The termination of any proceeding by conviction or upon a plea of nolo contendere or its equivalent or an entry of an order of probation prior to judgment creates a rebuttable presumption that the director did not meet the requisite standard of conduct required for permitted indemnification. The termination of any proceeding by judgment, order or settlement, however, does not create a presumption that the director failed to meet the requisite standard of conduct for permitted indemnification.

Indemnification under the provisions of the Maryland General Corporation Law is not deemed exclusive of any other rights, by indemnification or otherwise, to which a director or officer may be entitled under the Articles of Incorporation, Bylaws, resolution of shareholders or directors, contract or otherwise.

Insofar as indemnification for liabilities arising under the Securities Act may be permitted to directors, officers or persons controlling the Company pursuant to the foregoing provisions, the Company has been informed that in the opinion of the SEC such indemnification is against public policy as expressed in the Securities Act and is therefore unenforceable.
