### **DEERE TO RELEASE MONTHLY RETAIL-SALES COMMENT**

MOLINE, IL (October 2, 2006) Deere & Company today said it expects to release commentary on September 2006 retail sales next week. The AEM report is normally made public on or around the tenth day of the month.
