Of these shares, 5497.15 (74.15 earned pursuant to a dividend reinvestment plan) are owned by husband, 92,189.7 (11,779.7 earned pursuant to a dividend reinvestment plan) are held by reporting person and husband as custodian for children and 685,143.16 (15,146.16 earned pursuant to a dividend reinvestment plan) were contributed to a family partnership of which reporting person is a general partner. Reporting person disclaims beneficial ownership of the shares owned by husband and the shares held as custodian for children.
