EXPLANATORY NOTE

This registration statement is being filed solely for the registration of additional shares of common stock of The Ensign Group, Inc. (the "Company") for issuance pursuant to The Ensign Group, Inc. 2001 Stock Option, Deferred Stock and Restricted Stock Plan and The Ensign Group, Inc. 2007 Omnibus Incentive Plan (the "Plans"). Accordingly, pursuant to General Instruction E to Form S-8, the contents of the earlier registration statements relating to the Plans (Registration Nos. 333-148379; 333-157757; 333-172380 and 333-190552) are hereby incorporated by reference in this registration statement.
