The 49.2447 dividend equivalent rights being reported reflect 26.618 dividend equivalent rights at \$32.88 per RSU credited to the Reporting Person's account on 04/01/09 and 22.6267 dividend equivalent rights at \$38.68 per RSU credited to the Reporting Person's account on 07/01/09.
