On 11/15/11 the reporting person was granted a non-qualified stock option to purchase 164,000 shares, of which 82,000 shares will vest and become exercisable on each of 11/14/12 and 11/14/13 subject to the satisfaction of certain stock price performance conditions. The options will be forfeited if the applicable performance conditions have not been met by the expiration date.

(1) This option is no longer exercisable beginning on this date.

On 11/15/11 the reporting person was granted 54,000 restricted stock units ("RSUs"), 18,000 of which will vest on each of 11/15/12, 11/15/13 and 11/15/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
