Oberndorf ("WEO") and William J. Patterson ("WJP") the three controlling persons of SPO Corp. Additionally 374,500 shares of the issuer's common stock are owned directly by San Francisco Partners II, L.P. ("SF Partners"), and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P.
